



NOTIFICATION

Pursuant to the NATA – 2020 and IIT-JEE Paper 2 results published by the Council of Architecture and NTA, COMEDK hereby invites applications seeking admission to UG Architecture course for the academic year 2020-21, in the member institutions of COMEDK, from eligible candidates. The candidates have to fill the online application with a payment of Rs 1,000/- (Rupees one thousand only) as application fee. The list of Colleges who are accepting the merit determination of COMEDK during shis year along with the indicative number of seats and the tuition fee for the same would be notified on COMEDK website separately. The candidates are required to refer to the COMEDK website(www.comedk.org) for all updates.

GUIDELINES

Candidates are expected to go through the COMEDK UGET 2020 brochure and COMEDK counselling process document of engineering, related notifications and understand the process before applying for Architecture counselling. COMEDK suggest all the candidates to visit the COMEDK website regularly for all updates and notifications.

The process flow, procedure and all other terms & conditions as brought out in the Counseling Process Document for Engineering Courses are applicable for Architecture Courses also. Candidates have to refer to the said Counseling Process Document.

ELIGIBILITY FOR ARCHITECTURE COUNSELLING

Eligibility Criteria: As per the prevailing eligibility criteria of NATA & JEE, Candidates must have passed the NATA (National Aptitude Test in Architecture) conducted by Council of Architecture (CoA) or JEE Paper-2 and must have passed 2nd PUC /12th Std / Equivalent Exam with Physics, Chemistry, Mathematics or passed in 10+3 Diploma with Mathematics.

The merit list for the purpose of seat selection process will be drawn up based on 50% marks obtained in (a) Qualifying Examination and

(b) NATA or JEE Paper-2 taken together i.e. the aggregate of (a) and (b).

There shall be no separate entrance test for B.Arch.

Qualification in NATA is subject to the candidate getting at least cut-off marks in the two individual components and also getting at least the qualifying marks in aggregate.

The candidates will have option of entering scores of NATA and JEE Paper-2 if they have appeared for both. COMEDK will consider the scores of the any one entrance test whichever is beneficial to the candidate. If the candidates have appeared for only one exam, they have to enter the marks of that particular exam only.

Note:

- 1) Rank Card will be generated only for those candidates who become eligible for admission to Under Graduate Courses as per the regulations of COA /AICTE/ VTU and whose document verification is successful/approved.
- 2) In case of a 'Tie', the following tie breaker rules will be applied:
 - a) Higher % of marks in Entrance exam
 - b) Higher % of marks in Aptitude + Maths in Entrance Exam (since NATA score card does not show the aptitude marks separately)
 - c) Higher % of marks in Drawing Test
 - d) Elder candidate to be ranked higher

CANDIDATES INTERESTED IN BOTH ENGINEERING AND ARCHITECTURE

- a) A candidate who selects an Engineering seat in the first round may also be allotted a seat the first Round of Architecture. In the event of selecting and accepting an Architecture seat during the first round, the earlier selected Engineering seat automatically gets surrendered and added to the Second round of engineering seat matrix. Such a candidate will not be eligible to attend any further round of engineering counseling.
- b) A candidate who has not selected a seat in Engineering in the first round can attend the first round counseling of Architecture and select a seat. Further such a candidate is eligible to attend the second round of engineering counseling. In the event of selecting a seat in the second round of Engineering counseling, the earlier selected Architecture seat automatically gets surrendered and added to the Second round of Architecture seat matrix. However, such a candidate will not be eligible to attend any further round counseling of Architecture.

Further, all other terms and conditions set out in the counselling process document and other notifications shall prevail to the extent not contrary to the process/procedure explained above.

The candidates are required to visit the COMEDK website regularly for counselling status and all updates.
