### **COMEDK 2016 Medical and Dental UG Courses: Seat selection process pursuant to NEET results – documents required**

The Karnataka Professional Colleges' Foundation, comprising of 13 Medical and 24 Dental Unaided Private Professional College, has set up COMEDK, which is a Consortium of Medical, Engineering and Dental Colleges of Karnataka, and mandated to conduct a single window counseling for these member institutions so as to fill up approximately 700 MBBS and an equal number of BDS seats, based on the results of National Eligibility cum Entrance Test 2016, Phase-I and II. The results of NEET examination are reported to be announced sometimes in August 2016. In the light of the directions and orders of the Hon'ble Supreme Court in W.P. No. 261/2016 dtd. 28.04.2016 and 09.05.2016, admissions to Medical and Dental UG Courses shall be completed before 30<sup>th</sup> September 2016.

In the circumstances, COMEDK proposes to invite applications online shortly from the eligible candidates to participate in its seat selection process for selecting MBBS/BDS seats seeking admission in its member institutions during 2016-17. The eligibility criteria shall be as laid down by MCI/DCI including the NEET score.

In the meantime, with a view to familiarize the intending candidates in advance, an indicative list of original documents necessary for **submission mandatorily at the time of counseling by the candidates are as given below:**

- 1) Admit card of NEET UG 2016.
- 2) NEET – UG 2016 Mark sheet / Rank Card.
- 3) Copy of Online Application Form for participation in COMEDK counseling pursuant to NEET results.
- 4) SSC (or equivalent) passing certificate or any other Government document as proof of Date of Birth.
- 5) PUC/12<sup>th</sup> std. (or equivalent) examination marks sheet.
- 6) Applicable Caste Certificate issued by the Competent Authority (for Karnataka Candidates only).

- 7) OBC certificate issued by the competent Authority (for Karnataka Candidates only).
- 8) Minority certificate issued by the educational institution concerned (for Christian, Tulu and Telugu Minority of Karnataka and Non-Karnataka Christian candidates).
- 9) Domicile certificate, wherever necessary (for Karnataka Candidates only).
- 10) Parent domicile certificate, wherever necessary (for Karnataka Candidates only).
- 11) Eligibility Certificate for claiming seats reserved for Hyderabad Karnataka Region candidates issued by the Assistant Commissioner of the respective sub-division (applicable for Karnataka Candidates only).
- 12) Anyone of the valid photo ID proof:
  - i) Passport
  - ii) PAN Card
  - iii) Driving License
  - iv) Aadhaar Card / acknowledgment for Aadhaar Card
  - v) Voter's ID
  - vi) Certificate with photo issued by the Head of the Institution last studied

A few days before the announcement of NEET results, applications in this behalf would be invited and the candidates are required to fill in Online Form to be prescribed shortly, giving details of the documents as above. Also a detailed seat selection process document would be hosted on the website at the appropriate time.
