## CORRIGENDUM

### **COMEDK UGET 2016 – Surrender Policy and Eligibility Norms for Second and Final Round of Medical and Dental counselling.**

Whereas, in the calendar of events published on 10.08.2016 along with Counselling Brochure, it was mentioned that the dates for surrender of seats and conversion of provisional allotment into confirmed allotment would be from 13<sup>th</sup> to 17<sup>th</sup> September 2016;

Whereas, the Surrender Policy and Eligibility Norms for Second and Final Round of Medical and Dental counselling along with procedure thereof was notified on 07.09.2016;

Whereas, in the said notification dtd. 07.09.2016 it was informed that the candidates who have taken provisional allotment can surrender their seats online only by logging through their individual applicant login;

Whereas, it is felt necessary to notify the time frame within which the candidates can convert their provisional allotment into confirmed allotment or for surrender of seats selected during first round of Medical and Dental counselling;

Now therefore, the time frame along with venue for the said purpose is notified hereunder.

#### **A. Surrender of provisional allotments:**

From 5:00 PM of 13/09/2016 To 6:00 PM of 17/09/2016	Only online by logging into individual applicant login on COMEDK Website ( <a href="http://www.comedk.org">www.comedk.org</a> )

#### **Note:**

- Surrender of provisional seat in the mode and dates other than specified above is not permitted/acceptable.
- The candidates are required to give their Bank details such as Name of the Beneficiary, Bank, Branch, A/c Number, IFS Code.
- Amount will be remitted to their A/c within five working days after the last date for seat surrender.

**B. In person surrender of confirmed allotment letter and Conversion of provisional allotment into confirmed allotment::**

**Note:**

- Surrender of confirmed allotment letter or conversion of allotment will not be accepted other than the dates mentioned above.
- Only the candidates can surrender the confirmed allotment letter / convert the provisional into confirmed allotment in person at the counselling venue (no surrender of confirmed allotment letter or conversion of allotment will be accepted through Authorization, Phone, FAX, E-mail or Post)
- Candidates are required to bring COMEDK allotment letter, Bank receipt for having deposited the tuition fee and verification card all in original received by them.
- Refund amount for surrender of confirmed allotment will be paid by a crossed A/c payee cheque in the name of candidate only.

All other procedure would continue to be the same as prescribed in the Process Document notified on 01.09.2016 and Notification dtd. 07.09.2016; also the terms and conditions set out in the said notifications shall prevail to the extent not contrary to the procedure explained as above.
