GUIDELINES

1. Completing Online Application form for Counselling for Architecture

- Please fill the Counselling Application for Architecture Online
- The process involves registering and completing the counselling application for architecture by paying Rs 1150(This includes application and counselling fee of Rs 1000+ service tax of Rs 140 + Swacch Bharat cess of Rs 5+ Krishi Kalyan cess of Rs 5) during the prescribed time as per counselling schedule for Architecture available on www.comedk.org. Convenience charges on transaction will be additional.
- This fee is non-refundable under any circumstance including statutory reasons.

2. Option Entry and subsequent processes

- After successful payment, Option Entry Form will be available for the candidate.
- The option entry form has to be filled by the candidate during the prescribed time as mentioned in schedule.
- The candidate has to select the course and college and assign the preference number for each course and college selected during the prescribed time.
- Refer counselling process document for Engineering for all counselling related process and subsequent steps.

3. Document Verification

Architecture candidates have to bring all documents as mentioned in the counselling process document as applicable to them in addition to the below mentioned document;

- Valid Original NATA score card along with 2 self attested photo copies of the same.
- COMEDK TAT card is not applicable to Architecture candidates.

ANNUAL TUITION FEE PAYMENT AND FEE POLICY

The upper limit of annual tuition fee as agreed between the State Government and the Association of Colleges is Rs.1,70,000/- or Rs.1,21,000/- whichever is opted by the respective institutions.

Please note that: This fee amount may change subject to any revision in tuition fee by statutory authorities and is only indicative.

- Candidates and their parents/guardians should ensure that sufficient funds are maintained in their bank accounts keeping in view the Bank holidays. Subsequent requests for extension of time for the same will not be entertained.
- Cash or cheque or any other payment mode will not be accepted under any circumstances.
- Candidates have to check status of transaction with their banker and by checking the counselling process tab in applicant login.
- The fee receipt of Rs 55000/- will be available in “document required at time verification” tab in applicant login.

FEE REFUND AND FEE FORFEITURE
